

### What does a \$2.4 Billion Loan look like? Deal Highlights

#### 20 Year Fannie Mae Credit Facility with 5 Initial Full-Term Interest Only Advances

- Flexible Releases, Substitutions, Additions and "Borrow Ups"
- Blended Rate of 2.41%
- 7 Year Fixed Rate of 2.38% -\$220,500,000
- 10 Year Fixed Rate of 2.42% \$1,212,750,000
- 12 Year Fixed Rate of 2.54% \$551,250,000
- 15 Year Fixed Rate of 2.69% \$220,500,000
- 10 Year Floating Rate Advance \$195,000,000
  - 1.55% over LIBOR (Current Pay Rate of 1.73%)
  - 6 month Lock Out followed by open prepayment with no penalty

- Locked the Treasury and Spread in one week
- Went from application to funding in 60 days
- Underwrote 67 properties comprised of over 23,000 units, coordinated 207 separate property inspections, and reviewed 3,800 due diligence documents.
- Negotiated Master Credit Facility Agreement in 30 days
- Reviewed 149 insurance policies
- Executed the largest single defeasance ever
- All of this was done with all parties working from home for the last 6 weeks of the transaction
