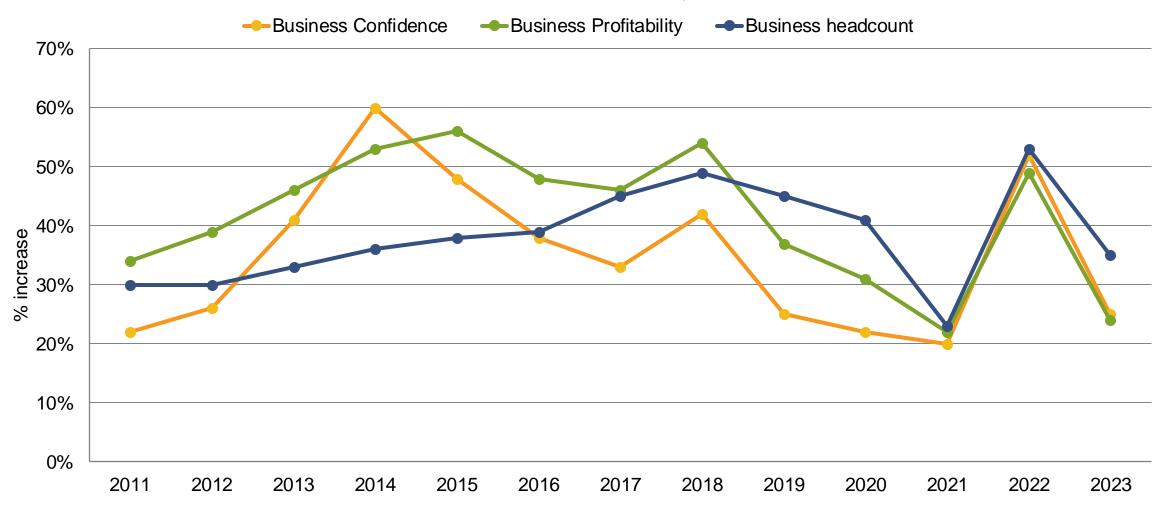

Real estate business sentiment, 2011-2023



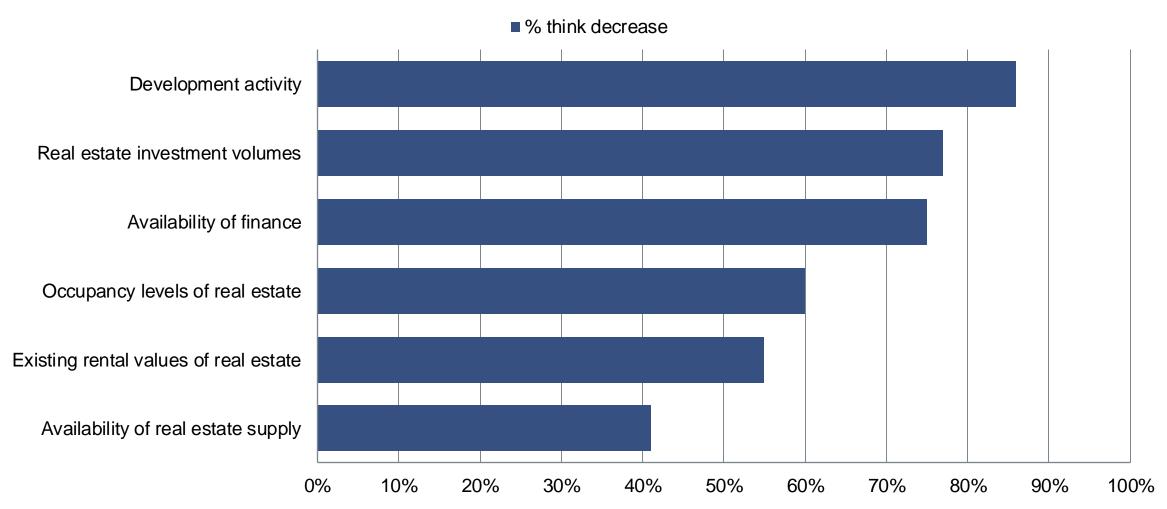

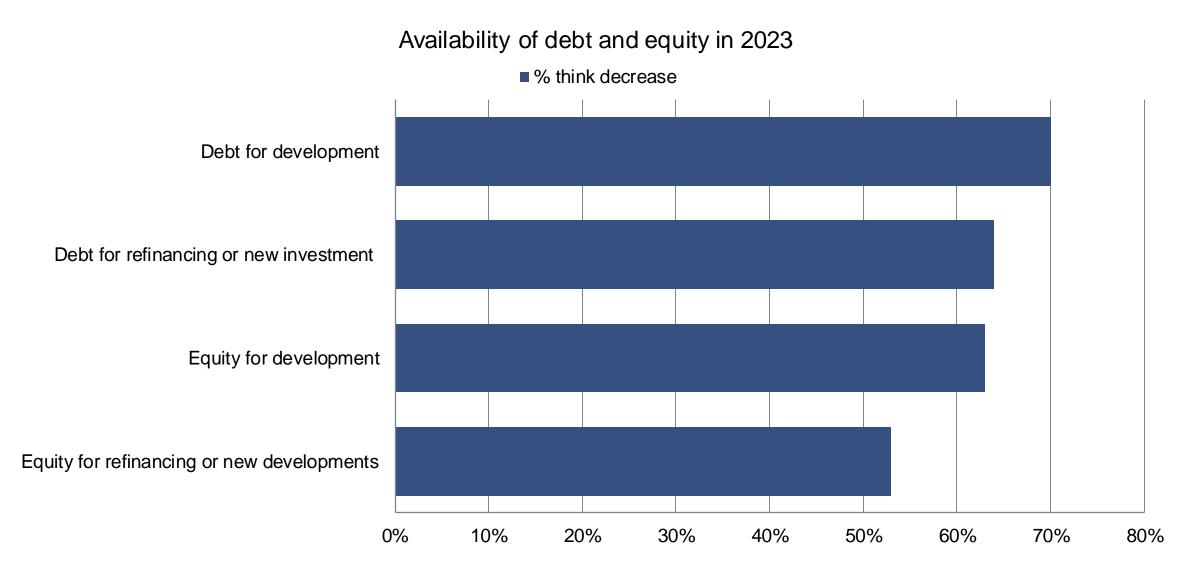
