| 00:01:34> 00:01:40: | About 35,000 of them, and we have a national organization |
| 00:01:40> 00:01:43: | of which this endeavor is apart. |

| 00:01:47> 00:01:51: | including one in Charlotte. You like just a bunch of |

| 00:02:22> 00:02:29: | as in this case the governmental agency educational institution, |

| 00:02:32> 00:02:35: | Taking a look at and making recommendations about a particular |

| 00:06:05> 00:06:07: | many people about the idea of Queens Park as it |
| 00:06:07> 00:06:09: | has been presented by the forensic. |

| 00:06:12> 00:06:17: | but we've heard lots of butts and the primary, |
| 00:06:17> 00:06:21: | but we heard I would encapsulate in this. |
| 00:06:21> 00:06:23: | It's not just about the park and you're going to |
| 00:06:23> 00:06:26: | hear more about that from the panelist as we go |
| 00:06:26> 00:06:26: | along. |
| 00:06:26> 00:06:29: | In particular, we've heard that it's about mobility. |
| 00:06:29> 00:06:34: | Both social mobility and physical mobility in terms of |
| | transportation, |

| 00:06:54> 00:06:58: | Where it matters. We've heard some hard what we perceive |
| 00:06:58> 00:07:00: | to be some fairly hard truth, |
| 00:07:00> 00:07:03: | given the questions that we've been asked. |
| 00:07:03> 00:07:07: | Katz is not moving. Come and you're going to hear |
| 00:07:07> 00:07:10: | our panelists talk about ways to respond to that. |
| 00:07:10> 00:07:12: | Norfolk Southern camping negotiated with, |
| 00:07:12> 00:07:15: | but I think we all realize that it's going to |
| 00:07:15> 00:07:15: | be a long haul. |

| 00:07:18> 00:07:19: | approach this, |
| 00:07:19> 00:07:22: | but short term, medium term and long term is 3 |

| 00:07:25> 00:07:29: | to take a long time to make that ultimate vision |
| 00:07:29> 00:07:31: | happen. We've heard that the North End can learn from |
| 00:07:31> 00:07:32: | the South end experience. |
| 00:07:32> 00:07:35: | South End took everybody in Charlotte by surprise, |
| 00:07:35> 00:07:39: | apparently, and there was some planning that didn't get done |
| 00:07:39> 00:07:42: | before the development exploded along the rail line there, |
| 00:07:42> 00:07:45: | and there's an opportunity in the North End that everyone |
| 00:07:45> 00:07:47: | acknowledged to learn from the lessons of the South, |
| 00:07:47> 00:07:49: | and we'll talk more about that. |
| 00:07:49> 00:07:54: | We've heard from a number of people that the process |
| 00:07:54> 00:07:57: | of pitching Queens Park has become, |
| 00:07:57> 00:08:00: | perhaps unintentionally but unnecessarily adversarial, |
| 00:08:00> 00:08:03: | and therefore there's some fence mending to be done, |
| 00:08:03> 00:08:08: | and some image corrections that can be made that can |
| 00:08:08> 00:08:12: | serve to the benefit of the idea of the park |
| 00:08:12> 00:08:16: | that bled into the other thing we heard that. |

| 00:08:18> 00:08:21: | But we perceived that in Charlotte, |

| 00:08:30> 00:08:35: | everyone pitching together in public private partnerships to |
| | make things |

| 00:10:33> 00:10:36: | you Alan. Good morning everyone. |
| 00:10:36> 00:10:37: | It's really my pleasure to be here. |
| 00:10:37> 00:10:40: | I run a public private partnership in Fort Lauderdale, |
| 00:10:40> 00:10:43: | FL. We focus on investment, |
| 00:10:43> 00:10:47: | growth and consistent improvement in our downtown urban core and |
| 00:10:47> 00:10:50: | my background largely spans in the public sector. |
| 00:10:50> 00:10:53: | I worked for the municipal government here for over 16 |
| 00:10:53> 00:10:54: | years, |
| 00:10:54> 00:10:57: | so I bring to the table and understanding of the |
| 00:10:58> 00:10:58: | politics, |
| 00:10:58> 00:11:03: | the Community engagement and really developing relationships too. |
| 00:11:03> 00:11:07: | Advance very important initiatives such as this. |
| 00:11:07> 00:11:11: | Next slide. So first and foremost, |
| 00:11:11> 00:11:14: | we wouldn't be here speaking with you all without the |
| 00:11:14> 00:11:18: | hard work and effort from friends of Queens Park and |
| 00:11:18> 00:11:21: | we really wanted to take time to credit the group |

| 00:11:23> 00:11:25: | if not years almost a decade, |
| 00:11:25> 00:11:29: | envisioning this Queens Park effort and really big ideas are |
| 00:11:29> 00:11:31: | often born in this manner. |
| 00:11:31> 00:11:35: | You have inspired others. We believe you've set the pathway |
| 00:11:35> 00:11:39: | for momentum and you've served as an instigator to really. |

| 00:11:43> 00:11:47: | so kudos in that regard and you know the the |
| 00:11:47> 00:11:51: | work that you've done certainly sets the stage. |

| 00:11:55> 00:12:00: | larger planning effort that really addresses Charlotte's growth strategy for |

| 00:12:05> 00:12:09: | plan is what's needed to really kick off this process, |
| 00:12:09> 00:12:12: | and part of that, as Alan just mentioned, |
| 00:12:12> 00:12:15: | is understanding some of these critical obstacles. |

| 00:12:42> 00:12:46: | you have a series of many wonderful prior planning efforts |
| 00:12:47> 00:12:50: | that have already set the stage for for the vision |
| 00:12:50> 00:12:51: | of larger, |
| 00:12:51> 00:12:54: | greater Charlotte, as well as parts of the North End |
| 00:12:54> 00:12:58: | and and these planning efforts have already engaged the public |
| 00:12:58> 00:12:59: | in meaningful ways. |

| 00:13:02> 00:13:07: | there's several overlapping guiding principles from the comprehensive plan, |
| 00:13:07> 00:13:11: | the county's Parks and Recreation master plan and center cities. |
| 00:13:11> 00:13:15: | 2040 vision that really allow us to address broader, |
| 00:13:15> 00:13:20: | relevant issues specific to the North End housing access for |
| 00:13:20> 00:13:23: | all safe and resilient public spaces. |
| 00:13:23> 00:13:27: | Equitable mobility and diversity. Equity and inclusion. |
| 00:13:27> 00:13:35: | Next prior to kicking off a zoomed out focus study |
| 00:13:35> 00:13:37: | for the North End. |
| 00:13:37> 00:13:40: | We feel that it's important to really recognize, |
| 00:13:40> 00:13:44: | acknowledge, and understand each partner's unique role. |
| 00:13:44> 00:13:46: | What they bring to the table, |
| 00:13:46> 00:13:49: | also, what their needs and goals are. |
| 00:13:49> 00:13:52: | When this is factored into the planning process, |
| 00:13:52> 00:13:56: | there's there sets up an opportunity for decision making by |
| 00:13:56> 00:14:00: | all partners that creates an environment for broad participation, |
| 00:14:00> 00:14:04: | and this is particularly true for the Community members, |
| 00:14:04> 00:14:08: | particularly who live in and under in underserved areas. |
| 00:14:08> 00:14:11: | That may have not shared in decision making along the |
| 00:14:11> 00:14:13: | course of these processes. |
| 00:14:13> 00:14:18: | Next so as we talk about kicking off the effort |
| 00:14:18> 00:14:22: | with a larger vision plan for the North End. |
| 00:14:22> 00:14:27: | We're essentially looking at a new structure for a taskforce |

| 00:14:29> 00:14:34: | We believe fundamentally, the public sector should be responsible and |
| 00:14:34> 00:14:39: | in charge of leading the planning effort as they've done |
| 00:14:39> 00:14:40: | with other projects, |
| 00:14:40> 00:14:43: | and this could be a joint collaboration between the city |

| 00:14:48> 00:14:51: | with other area plans with that really. |
| 00:14:51> 00:14:56: | Understanding who the Champions are from the elected official levels, |
| 00:14:56> 00:15:00: | we had the pleasure to interview several elected officials and |
| 00:15:01> 00:15:05: | having champions at that level really helps drive progress in |
| 00:15:05> 00:15:07: | momentum on these larger projects. |
| 00:15:07> 00:15:12: | Also, the executive administration at the public sector level. |
| 00:15:12> 00:15:16: | Being a county or city organization that has several different |
| 00:15:16> 00:15:16: | departments, |
| 00:15:16> 00:15:22: | sometimes competing needs resources or even goals, |
| 00:15:22> 00:15:25: | it's important to have leaders that run these type of |
| 00:15:25> 00:15:30: | planning efforts that can manage a variety of stakeholders within |
| 00:15:30> 00:15:31: | their organizations. |

| 00:15:32> 00:15:35: | and again, Alan briefly touched on it. |
| 00:15:35> 00:15:41: | Charlotte has benefited over decades from very visible private sector |
| 00:15:41> 00:15:42: | leaders, |
| 00:15:42> 00:15:46: | often times at the CEO levels who don't necessarily have |
| 00:15:46> 00:15:47: | direct skin in the game. |
| 00:15:47> 00:15:50: | When it comes to these type of planning efforts or |

| 00:15:52> 00:15:56: | but carry the water to help pull the Community forward |
| 00:15:56> 00:15:58: | to implement these type of projects. |
| 00:15:58> 00:16:02: | Also, as part of the private sector taskforce, |
