00:08:56> 00:08:59:	improvements? It's clear that the park, while it gets a
00:08:59> 00:09:03:	lot of attention, it's recognized as an important asset that
00:09:03> 00:09:07:	the accountability for how it's managed and how it progresses
00:09:07> 00:09:10:	is not clear and governance might be an issue that
00:09:10> 00:09:15:	there's some improvement possible. Also, the experience of the user.
00:09:15> 00:09:18:	How? How do how does the community engage with that
00:09:18> 00:09:22:	park out of the regional customers engage? What does that
00:09:22> 00:09:22:	experience?
00:09:22> 00:09:25:	Like when you when you do engage with the park,

00:09:28> 00:09:30:	to make that a more full experience and then look

00:09:36> 00:09:40:	acre park next to a number of neighborhoods that feel
00:09:40> 00:09:44:	disconnected from the park in some cases but also recognize
00:09:44> 00:09:47:	it as a very important asset of their community. So
00:09:47> 00:09:50:	how do we start to look at that? That win
00:09:50> 00:09:54:	win between the park as it progresses and the benefits
00:09:54> 00:09:58:	to the residents. The long standing resonance that are

00:10:42> 00:10:47:	the curse. Trying to maintain that resource, that asset is
00:10:47> 00:10:52:	extremely challenging and it is currently under resourced. It does
00:10:52> 00:10:55:	not have the attention that it needs to be to
00:10:56> 00:11:01:	fully leverage its potential. The neighboring communities that are almost
00:11:01> 00:11:03:	70,000 residents.
00:11:03> 00:11:07:	Or they're underserved by the park. The park does not
00:11:07> 00:11:10:	in all cases feel like their park just feels like
00:11:10> 00:11:13:	another piece of real estate next door. So how does?
00:11:13> 00:11:16:	How does the neighborhood engage with this park and feel
00:11:16> 00:11:20:	like it's part of their neighborhood and something that belongs
00:11:20> 00:11:22:	to them is certainly an issue.

00:11:27> 00:11:31:	in some cases programmatically. So how do we improve those

00:12:14> 00:12:19:	are poor. The programmatic offerings are conspicuously lacking.

00:12:25> 00:12:28:	we start to look at the magnitude of that under
00:12:28> 00:12:32:	resourced asset four to five times more resources than it
00:12:32> 00:12:36:	is currently currently being allocated to. This to the park.
00:12:36> 00:12:40:	There are really two few amenities in the park. Given
00:12:40> 00:12:43:	the scale of the park and that is an issue
00:12:43> 00:12:47:	1 to emphasize, there are many good great components of
00:12:47> 00:12:51:	the park. You know the zoo, the Please touch museum.
00:12:51> 00:12:55:	The man Center all the historic venues this beautiful facility.
00:12:55> 00:12:58:	Many good pieces to the park but we are here
00:12:58> 00:13:01:	to talk about what's not working.
00:13:01> 00:13:04:	And so, while we may seem a little bit critical,
00:13:04> 00:13:07:	we understand that there are many pieces of the park
00:13:08> 00:13:11:	that we're everybody should be proud of and and be
00:13:11> 00:13:12:	happy to to be a part of.

00:14:26> 00:14:29:	to how the park is used, the events that are
00:14:30> 00:14:34:	held has created some frustrations and inconvenience and

	certainly has

00:14:38> 00:14:41:	is the last one to know whether or not an
00:14:41> 00:14:45:	event is being held and how how it might relate
00:14:45> 00:14:48:	to the greater community. Local engagement.

00:14:51> 00:14:54:	more set up for the regional visitor and not the
00:14:54> 00:14:55:	neighborhood visitor.

	to

00:15:08> 00:15:12:	difficult. Moving around the park is difficult. It's not intuitive
