00:04:39> 00:04:44:	panel to consider fell in, fell into three general categories,
00:04:44> 00:04:49:	placemaking, wayfinding and identity. In this category, we were asked
00:04:49> 00:04:53:	to consider how to enhance pathway awareness and the brand
00:04:54> 00:04:59:	of pathways in Meridian, improve wayfinding and promote, promote activation
00:04:59> 00:05:04:	of the pathways. The second category was improving access and
00:05:04> 00:05:06:	acceleration of implementation.
00:05:06> 00:05:12:	That included looking at procuring easements, fostering community collaboration for
00:05:12> 00:05:17:	connectivity, providing pedestrian access for older parts of Meridian where
00:05:17> 00:05:22:	when the subdivision was built the pathways were not originally
00:05:22> 00:05:26:	included, and improved access and equity considerations is the third
00:05:26> 00:05:31:	category increasing looking at ways to increase equitable access to
00:05:31> 00:05:36:	the existing trail, connecting across existing gaps in the system,
00:05:36> 00:05:37:	and addressing existing.
00:05:37> 00:05:38:	Barriers.
00:05:40> 00:05:43:	You're going to see in our recommendations that we don't
00:05:44> 00:05:47:	actually go through and answer each of those questions in
00:05:47> 00:05:48:	order we.
00:05:50> 00:05:54:	We've been thinking about how to answer those questions in
00:05:54> 00:05:58:	a holistic way. And So what you're going to see
00:05:58> 00:06:02:	is a presentation that that cuts across those categories with
00:06:02> 00:06:07:	a series of recommendations. But the most important thing

Meridian has been quite successful in creating critical mass of pathways along your irrigation system. You're an example for the the region and how to do that and so. This is taking things to the next level. These recommendations

OK. So I'd like to start by talking 00:07:26 --> 00:07:29: about how we think about purpose and. 00:07:32 --> 00:07:35: Of course, you've been thinking about purpose since you began. You'll probably begin by, you know, asserting a purpose and 00:07:35 --> 00:07:38: 00:07:38 --> 00:07:40: in doing it. But one of the things that we 00:07:40 --> 00:07:43: recommend is returning to look at that purpose and think 00:07:43 --> 00:07:46: about it again as where you are. So if you're 00:07:46 --> 00:07:48: going to make a big leap forward, you would need 00:07:49 --> 00:07:51: to make sure that's based on the purpose that you 00:07:51 --> 00:07:54: now feel that this system that you've already built and 00:07:54 --> 00:07:57: that you continue to build out will serve. And purpose 00:07:57 --> 00:07:59: and use are a little different. 00:08:00 --> 00:08:02: The purpose of a cookbook may be to make me 00:08:03 --> 00:08:05: a better cook, but I actually use it for new 00:08:05 --> 00:08:09: ideas for meals, ingredients, or spices. All of these uses

00:08:09 --> 00:08:12: come together to make me a better cook. Brand, which 00:08:12 --> 00:08:15: you've asked us to think about is a visual or 00:08:15 --> 00:08:19: short text reference to purpose and story. So sometimes we 00:08:19 --> 00:08:22: think about brand and we may confuse it with wayfinding. 00:08:22 --> 00:08:26: Wayfinding is a little different than that. The brand tells 00:08:26 --> 00:08:29: me what to expect, and particularly when you're when you're

00:08:30> 00:08:34:	Multifold and includes different types of uses. We have to
00:08:34> 00:08:37:	be careful in our in our branding to represent that
00:08:37> 00:08:40:	entire purpose. So why do you have a pathway system?
00:08:40> 00:08:43:	I come from a pathway community and in our community.
00:08:43> 00:08:46:	The purpose of our pathway is to have a more
00:08:46> 00:08:50:	enjoyable community and to create value in the community.
00.00.40 7 00.00.00.	It,
00:08:50> 00:08:53:	it and you know people along the pathway have higher
00:08:53> 00:08:57:	property values. People who can access the pathways have higher
00:08:57> 00:09:00:	property values. But that's not the primary reason we do
00:09:00> 00:09:01:	it.
00:09:01> 00:09:04:	We do it because it's enjoyable and a lot of
00:09:04> 00:09:07:	the design goes to that enjoyment element.
00:09:08> 00:09:11:	Use though is of course a part of purpose, and
00:09:11> 00:09:15:	when there are multiple uses, they may have a hierarchy
00:09:15> 00:09:18:	or they may be divided up among different parts of
00:09:18> 00:09:22:	of of the system. So one of the questions we'd
00:09:22> 00:09:24:	ask you to to look at as you focus on
00:09:24> 00:09:28:	your branding and you think about your your system is
00:09:28> 00:09:31:	what's the hierarchy of uses in your pathway system.
00:09:32> 00:09:36:	And we've thought some about both how it appears to
00:09:36> 00:09:39:	us and how it might be that you want to
00:09:39> 00:09:42:	structure it going going forward. And this is kind of
00:09:42> 00:09:46:	how the hierarchy it's that mix of appears and and
00:09:46> 00:09:49:	and it might be thought of going forward. So level
00:09:49> 00:09:54:	one is major destination commuting routes and commuting is the
00:09:54> 00:09:58:	operative word there. 10 mile, five mile loop, the path
00:09:58> 00:10:01:	to the Greenway, these are paths that you've thought of
00:10:02> 00:10:02:	as wider.
00:10:02> 00:10:06:	Maybe they are paths that accept bicycles moving at faster
00:10:06> 00:10:10:	speeds. They're different in quality than the other pathways in
00:10:10> 00:10:13:	in the system because they serve a different use.
00:10:14> 00:10:18:	They've also maybe have different branding markers. They may be
00:10:18> 00:10:22:	cut. There may be color-coded markers to identify the commuting
00:10:22> 00:10:25:	routes and important destinations. But they also have to be
00:10:25> 00:10:28:	designed so that they can be read on a bike
00:10:28> 00:10:31:	moving rapidly. So that actually uses a different sort of

00:10:31> 00:10:35:	design than somebody hiking needs when they're trying to make
00:10:35> 00:10:39:	decisions at different points. Another level, maybe the grid of
00:10:39> 00:10:43:	neighborhood destination routes in pathways. Much of the discussion is
00:10:43> 00:10:45:	about where am I going?
00:10:45> 00:10:48:	And one of the purposes is often to go somewhere.
00:10:48> 00:10:51:	And we talk about this sometimes as there are times
00:10:51> 00:10:54:	that people want to go out and just walk round
00:10:54> 00:10:57:	and round for exercise or but they would walk their
00:10:57> 00:11:00:	dog. But many times people are using pathways to go
00:11:00> 00:11:03:	somewhere. And so destination is an integral part of a
00:11:03> 00:11:07:	pathway system and the communication that goes along there and
00:11:07> 00:11:11:	those neighborhood destinations may be local parks, third places, schools,
00:11:11> 00:11:14:	they may have different kinds of icons than the routes
00:11:15> 00:11:16:	for these popular.
00:11:16> 00:11:19:	Local destinations and it they may be used differently depending
00:11:20> 00:11:22:	on the time of day. Sometimes of the day there
00:11:22> 00:11:25:	may be faster bikes on there because there's no other
00:11:25> 00:11:28:	traffic on them. But other times of the day, it's
00:11:28> 00:11:32:	unacceptable for those faster bikes to be there, and they
00:11:32> 00:11:35:	should be using alternative bike routes that you also have
00:11:35> 00:11:38:	a lot of now or in development. And third places
00:11:38> 00:11:42:	are those places where the community gathers. They're the church,
00:11:42> 00:11:45:	the the the, the pub there, the school, any place
00:11:45> 00:11:46:	the community gathers.
00:11:47> 00:11:50:	Those are important in those local grids and to and
00:11:50> 00:11:53:	to let the Community help name those that you know
00:11:53> 00:11:56:	as part of what's going on the third level is
00:11:56> 00:12:00:	this level of recreation and that's walking jogging walking my
00:12:00> 00:12:04:	dog playing path parties so that neighborhoods you know take
00:12:04> 00:12:08:	ownership of their their paths in terms of something that
00:12:08> 00:12:12:	they feel close to and are amenities jogging clubs in
00:12:12> 00:12:15:	our community jogging groups will come in from the schools
00:12:15> 00:12:17:	that their track.
00:12:17> 00:12:20:	Clubs, and they will use that community pathway to enjoy
00:12:20> 00:12:23:	a different scene from their normal jobs. Those are usually
00:12:23> 00:12:26:	marked in chalk. We don't, you know, no one tries
00:12:26> 00:12:29:	to put those routes in there because they vary from

00:12:29> 00:12:32:	time to time. And that's actually part of the enjoyment
00:12:32> 00:12:35:	of these local pathway systems is seeing the different ways
00:12:35> 00:12:38:	that they're used and the different things that are going
00:12:38> 00:12:42:	on. It's part of what makes them interesting, particularly if
00:12:42> 00:12:43:	you're using them every day.
00:12:45> 00:12:47:	Then the last thing is as a platform, all of
00:12:47> 00:12:51:	your pathways are platforms for other things in your vision
00:12:51> 00:12:54:	as we understand it. You want art there, you've been
00:12:54> 00:12:57:	interested in putting history there. Those are things that we
00:12:57> 00:13:01:	think of as platforming and they can include art installations,
00:13:01> 00:13:06:	the local school art, historic information and interpretations, structures that
00:13:06> 00:13:09:	relate to the community. We've thought about your mid block
00:13:09> 00:13:12:	crossings and in some communities those are done with art
00:13:12> 00:13:15:	pieces they so you know where a mid block.
00:13:15> 00:13:19:	Crossing occurs and they may be different in one neighborhood
00:13:19> 00:13:22:	or the next. And there's a lot of thought that
00:13:22> 00:13:25:	are put into this and there's a lot of opportunity
00:13:25> 00:13:29:	monuments that are backgrounds for Instagrams integrated into OK, those
00:13:29> 00:13:32:	may be more appropriate in a transit loop that maybe
00:13:32> 00:13:36:	other people are coming through the community and that's something
00:13:36> 00:13:39:	that would be fun for them and also a chance
00:13:39> 00:13:42:	for your community to have an appearance at their. So
00:13:42> 00:13:45:	all of these things, I naturalist is one that I
00:13:45> 00:13:47:	like because it's a way of.
00:13:47> 00:13:50:	It's a app that lets you take a picture of
00:13:50> 00:13:53:	a bird or butterfly or a snake and and you
00:13:53> 00:13:55:	say I think this is a thus and such and
00:13:55> 00:13:59:	other people who have more experience come in and say
00:13:59> 00:14:03:	yes that's us and such and and that actually accumulates
00:14:03> 00:14:06:	as information on your pathways so that other people can
00:14:07> 00:14:10:	come along with that program and say Oh well, in
00:14:10> 00:14:13:	this area there are woodchucks or whatever it is that
00:14:13> 00:14:16:	is going on. That's a part of place making all
00:14:16> 00:14:17:	of those things.
00:14:17> 00:14:21:	The, the, the agriculture that's going on, the history
00:14:21> 00:14:25:	that's going on, the wildlife that are going on, that's
00:14:25> 00:14:28:	all part of placemaking. You may look at this and
00:14:28> 00:14:31:	say, well, #4 is actually part for us of #1.
00:14:32> 00:14:35:	And I don't want to suggest that everything has to

00:14:35> 00:14:38:	be approached in hierarchy. It's just that there are natural
00:14:38> 00:14:42:	hierarchies there, and they're not all equal. They're never all
00:14:42> 00:14:45:	equal, but they may be mixed and and you'll think
00:14:45> 00:14:47:	about how best to serve them.
00:14:51> 00:14:54:	But every path doesn't have to serve every use. Some
00:14:54> 00:14:58:	are wider, some are more scenic, some have fewer gaps
00:14:58> 00:15:01:	or crossings, some are local, and some are regional. And
00:15:01> 00:15:05:	even a path will eventually serve a use. It doesn't
00:15:05> 00:15:08:	have to happen today, and it's really important to not
00:15:08> 00:15:12:	make places feel incomplete because they haven't yet gotten to
00:15:12> 00:15:15:	all of the uses that you ultimately want to to
00:15:15> 00:15:19:	serve. In some ways, we were so impressed with the
00:15:19> 00:15:20:	system that you already have.
00:15:21> 00:15:24:	And in a little bit of its under appreciation for
00:15:24> 00:15:28:	what's already there and excitement about the things that are
00:15:28> 00:15:32:	to come rather than well, this hasn't got the thus
00:15:32> 00:15:35:	and such yet. It really is a phenomenal thing that
00:15:35> 00:15:39:	you've already done, you know, and not every connection has
00:15:39> 00:15:43:	to be made today. It doesn't have to be immediate
00:15:43> 00:15:46:	or even before the purpose of the system is being
00:15:46> 00:15:51:	served. So connectivity may serve the purpose, but typically.
00:15:51> 00:15:54:	Connectivity is not the purpose of a pathway.
00:15:55> 00:15:59:	And that's important to understand because some connections will wait
00:15:59> 00:16:02:	until a future circumstance in which they can be achieved.
00:16:02> 00:16:06:	A neighborhood changes its mind, a holdout is replaced, a
00:16:06> 00:16:10:	neighborhood purchases an easement, redevelopment occurs and that creates an
00:16:10> 00:16:13:	opportunity. But in the meantime, we thought a lot about
00:16:14> 00:16:17:	what we call temporary routing alternative connections and that's the
00:16:18> 00:16:21:	sidewalks and the bike trails that you are also developing
00:16:21> 00:16:24:	right, right now. And those provide, we call those tracks
00:16:24> 00:16:25:	and you'll hear us.
00:16:25> 00:16:29:	Refer to track several times here, but those provide temporary
00:16:29> 00:16:33:	connections for functional purposes alright, so still keeping purpose in
00:16:33> 00:16:37:	mind and saying OK, I don't have this connection yet,
00:16:37> 00:16:39:	but I can use my tracks to continue to meet
00:16:39> 00:16:40:	my purpose.

00:16:43> 00:16:46:	We also think equity is part of purpose and you
00:16:46> 00:16:49:	specifically ask us to address equity in different ways. But
00:16:49> 00:16:53:	you have to begin that discussion by understanding what you
00:16:53> 00:16:56:	mean by equity and and how you're going to think
00:16:56> 00:16:59:	about it and what standard you're going to apply, because
00:16:59> 00:17:02:	there are a lot of ways to approach equity. And
00:17:02> 00:17:06:	we offer an example, there's UI's 10 principles for an
00:17:06> 00:17:09:	enhancing equitable access to parks. And one way to think
00:17:09> 00:17:12:	about your pathway system is it is your largest parks
00:17:12> 00:17:13:	park.
00:17:13> 00:17:15:	There is a park in and of itself. It serves
00:17:15> 00:17:20:	different functions throughout. It's spread everywhere. It's connecting other parks,
00:17:20> 00:17:23:	it's destination. But it is a park. So what are
00:17:23> 00:17:26:	its equitable standards? What are you looking for in that?
00:17:26> 00:17:29:	And you might begin. We're just suggesting this. You have
00:17:30> 00:17:33:	to decide what you want that equitable service to be.
00:17:33> 00:17:35:	But you might begin by by saying, OK, is every
00:17:35> 00:17:38:	resident within a 10 minute walk of access to a
00:17:38> 00:17:41:	path or path connection route? They might be. Oh, I
00:17:41> 00:17:43:	have to go a little further down.
00:17:43> 00:17:46:	The sidewalk or, you know, a bike trail. But does
00:17:46> 00:17:49:	can everybody get to the system within 10 minutes? And
00:17:49> 00:17:52:	if not, that helps you think about how to expand
00:17:53> 00:17:53:	the system.
00:18:02> 00:18:05:	You also though to to talk about equity, you have
00:18:05> 00:18:10:	to identify the underserved neighborhoods and populations, and you have
00:18:10> 00:18:13:	to assure comparable access to the system. That is not
00:18:14> 00:18:17:	the same access comparable means you have in mind are
00:18:17> 00:18:20:	this is this is this a question of equal access
00:18:20> 00:18:24:	or is it a question of different needs, a different
00:18:24> 00:18:24:	thing?
00:18:24> 00:18:27:	It should be served in in this area. And so
00:18:27> 00:18:31:	there's another principle and there's 10 principles, which is connect
00:18:31> 00:18:35:	people to parks. And another step in thinking about equity
00:18:35> 00:18:39:	is make certain that the pathway program is reaching all
00:18:39> 00:18:43:	neighborhoods and is serving all groups. Eventually doesn't have to
00:18:43> 00:18:46:	all be today. And in some areas, ADA access may
00:18:46> 00:18:50:	need to be prioritized or a different amenity tailored for
00:18:50> 00:18:53:	a blind resident or a group of blind residents. That

00:18:53> 00:18:54:	accent garden is more
00:18:54> 00:18:59:	assent garden is more.  Valuable, then, a visual amenity Siri wants to talk to.

00:19:05> 00:19:09:	to adjust according to the what who you're talking about
00:19:09> 00:19:10:	equity with regard to.
00:19:12> 00:19:15:	And I wanted to give some quick examples of application
00:19:15> 00:19:16:	of equitable principles.
00:19:18> 00:19:21:	Design that deals with safety perception issues. Without
00.13.10> 00.13.21.	getting into
00:19:21> 00:19:24:	an argument as to whether a place is safe or
00:19:24> 00:19:26:	unsafe, you have one of the safest towns in the
00:19:27> 00:19:30:	in the country. But without getting into an argument as
00:19:30> 00:19:32:	to whether it's actually safe, there are places in a
00:19:33> 00:19:35:	system that people may perceive as not as safe for
00:19:35> 00:19:38:	them, and that has to do with eyes on the
00:19:38> 00:19:41:	path. Sometimes we talk about eyes on the street, but
00:19:41> 00:19:43:	eyes on the path, which is one of the things
00:19:43> 00:19:46:	you've been dealing with in your design right now saying,
00:19:46> 00:19:48:	OK, offense can't exceed 4 feet.
00:19:48> 00:19:51:	And then it has to be transparent, but that has
00:19:51> 00:19:54:	real impact on users and in some places as to
00:19:54> 00:19:57:	whether the path can be seen from houses and whether
00:19:57> 00:20:00:	they feel safe on those parts of the safe path
00:20:00> 00:20:04:	where they can't be. Same thing as in those instances
00:20:04> 00:20:06:	where you sort of end up with a cannon of
00:20:06> 00:20:10:	a Canyon, a fence and people feel a little nervous
00:20:10> 00:20:13:	about going down, that it also changes the aesthetics. And
00:20:13> 00:20:16:	so thinking about that as an equity issue, have we
00:20:17> 00:20:18:	dealt with that in our design?
