00:02:39> 00:02:42:	Osborne a little bit about Mr Osborne,
00:02:42> 00:02:45:	she was first elected as MLA to mid Island Pacific
00:02:45> 00:02:49:	Rim in 2020 and was soon after appointed the Minister
00:02:49> 00:02:50:	of Municipal Affairs.
00:02:50> 00:02:52:	The minister grew up in Vancouver Island,
00:02:52> 00:02:54:	has lived in Tofino for over 20 years,
00:02:54> 00:02:57:	first moving there back to work as a fisheries biologist
00:02:57> 00:03:00:	for the new Channel news in in Council and later
00:03:00> 00:03:04:	his executive director of a local education nonprofit.
00:03:04> 00:03:06:	Our environmental education nonprofit out there,
00:03:06> 00:03:08:	but I think is really apropos for this conversation,
00:03:08> 00:03:10:	and likely why she is the minister.
00:03:10> 00:03:14:	The minister was the Mayor of Chino from 2013 to
00:03:14> 00:03:17:	2020 and also chair and vice chair of the Alberni
00:03:17> 00:03:19:	Clayoquot Regional District.
00:03:19> 00:03:23:	Her time and local government shared a number of different
00:03:23> 00:03:24:	committees.
00:03:24> 00:03:26:	I think most interesting that Defino Housing Corporation,
00:03:26> 00:03:28:	which I myself am a little familiar with,
00:03:28> 00:03:30:	so maybe we'll get to touch on that a bit
00:03:30> 00:03:33:	and was chair of the board of Island Coastal Economic
00:03:33> 00:03:34:	Trust,
00:03:34> 00:03:36:	which. Economic housing those things are all tide,
00:03:36> 00:03:38:	so I think it it leads to a lot of
00:03:38> 00:03:39:	interesting background.

00:04:00> 00:04:02:	It's good to be doing this in a Safeway and
00:04:02> 00:04:04:	I'm really thrilled to be here today.
00:04:04> 00:04:06:	It's going to be a great opportunity to.
00:04:06> 00:04:09:	I'll make a few remarks on some of the projects
00:04:09> 00:04:10:	that I'm working on.
00:04:10> 00:04:13:	The initiatives that our government is working on and obviously
00:04:13> 00:04:16:	very much focused on housing and then get into some
00:04:16> 00:04:17:	discussion with Duncan,
00:04:17> 00:04:20:	which I'm really looking forward to and and your questions
00:04:20> 00:04:20:	as well,
00:04:20> 00:04:24:	so I'd like to start off 2 by acknowledging that.
00:04:24> 00:04:27:	I am speaking to you from the territory of the
00:04:27> 00:04:29:	Laquinton speaking peoples.
00:04:29> 00:04:32:	The Esquimalt and Songs, nations and again thank you for
00:04:32> 00:04:34:	inviting me to join all of you.
00:04:34> 00:04:36:	It is a real pleasure to be speaking to you
00:04:36> 00:04:38:	in for the first time for me to speak to
00:04:38> 00:04:41:	this group in my role as the Minister of Municipal
00:04:41> 00:04:44:	Affairs and as the Minister of Municipal Affairs.
00:04:44> 00:04:48:	I'm very grateful for the opportunity to work with partners
00:04:48> 00:04:52:	committed to building stronger and more resilient communities in British
00:04:52> 00:04:53:	Columbia.
00:04:53> 00:04:56:	And so, whether that's in Metro Vancouver.
00:04:56> 00:04:59:	The Fraser Valley in communities across the province.
00:04:59> 00:05:03:	Housing is a cornerstone of this work and I think
00:05:03> 00:05:04:	as you hopefully all know,
00:05:04> 00:05:07:	the premier has mandated me to work with the Minister
00:05:08> 00:05:09:	responsible for housing,
00:05:09> 00:05:12:	David Eby, to help bring down the cost of housing
00:05:12> 00:05:15:	to help get people into housing to work with local
00:05:15> 00:05:19:	governments and streamlining and modernizing the development,
00:05:19> 00:05:23:	permitting and approvals processes. And this is collaboration that's well
00:05:23> 00:05:23:	underway.
00:05:23> 00:05:26:	I'm going to share some more of the work to
00:05:26> 00:05:26:	date.
00:05:26> 00:05:28:	That we've been doing, and I know we'll get into
00:05:28> 00:05:31:	some some Q&A with Duncan and discussion about it too.

00:05:31> 00:05:33:	But today is also for me,
00:05:33> 00:05:36:	an opportunity to hear directly from all of you,
00:05:36> 00:05:39:	and I want to hear your feedback and discuss how
00:05:39> 00:05:43:	we can continue to collaborate to help get the homes
00:05:43> 00:05:45:	that British Columbians need right now.
00:05:45> 00:05:49:	Built faster. I have always been an extremely collaborative
	person
00:05:49> 00:05:52:	and I've always believed that we get our best work
00:05:52> 00:05:54:	done when we're working together.
00:05:54> 00:05:57:	So for you as developers and housing advocates,
00:05:57> 00:05:59:	I know that you are on the front lines.
00:05:59> 00:06:03:	Delivering on housing needs in urban communities across the province
00:06:03> 00:06:06:	and it's conversations like this one today that helped to
00:06:06> 00:06:09:	inform me they helped to inform our future policy and
00:06:10> 00:06:12:	they helped to deliver on our shared goal of housing.
00:06:12> 00:06:15:	British Columbians. As Duncan mentioned,
00:06:15> 00:06:19:	I was the mayor of Tofino and since first being
00:06:19> 00:06:21:	elected as mayor of Fino,
00:06:21> 00:06:24:	I've been deeply committed to collaboration between all orders of
00:06:24> 00:06:25:	government.
00:06:25> 00:06:29:	With the development sector and particularly focused on tackling the
00:06:29> 00:06:30:	housing crisis in our communities.
00:06:30> 00:06:33:	And I do know that it can be very tough
00:06:33> 00:06:33:	work.
00:06:33> 00:06:35:	It does require us to all roll up our sleeves
00:06:35> 00:06:38:	and its work that our government is deeply committed to
00:06:39> 00:06:39:	advancing,
00:06:39> 00:06:43:	because everyone deserves a place to call home.
00:06:43> 00:06:47:	So tackling the housing crisis requires work that supports a
00:06:47> 00:06:48:	long term vision,
00:06:48> 00:06:52:	and as you know, in 2018 our government launched homes
00:06:52> 00:06:52:	for BC,
00:06:52> 00:06:55:	which is the largest investment in housing affordability ever in
00:06:55> 00:06:56:	our province.
00:06:56> 00:07:02:	\$7 billion / 10 years to deliver 114,000 affordable homes.
00:07:02> 00:07:05:	And since then, since that time we've made some real
00:07:05> 00:07:08:	progress with more than 30,000 homes that are complete or
00:07:08> 00:07:11:	underway for people who are struggling to find a place
00:07:11> 00:07:14:	to live. And this might be seniors.
00:07:14> 00:07:17:	Students, people who are experiencing homelessness.

00:07:17> 00:07:21:	These are homes that are benefiting British Columbians in every
00:07:21> 00:07:22:	corner of our province.
00:07:22> 00:07:26:	We've also invested an additional 2 billion to finance the
00:07:26> 00:07:30:	construction of 9000 new homes for middle income families,
00:07:30> 00:07:32:	but we know there is an incredible amount of work
00:07:32> 00:07:33:	still to do,
00:07:33> 00:07:36:	and that's why Minister EV and I are very committed
00:07:36> 00:07:39:	to working with the development sector and working with local
00:07:39> 00:07:42:	governments to meet housing needs in growing communities.
00:07:42> 00:07:45:	So I'm very grateful for your work.
00:07:45> 00:07:47:	And your continued partnership with the province.
00:07:47> 00:07:49:	But as I spoke about at the start,
00:07:49> 00:07:52:	if we are to be successful at managing the housing
00:07:52> 00:07:53:	issues that we're facing today,
00:07:53> 00:07:57:	we we do need to collectively understand our end goal
00:07:57> 00:07:59:	and we need a vision.
00:07:59> 00:08:02:	Our government recognizes that a critical piece of supporting housing,
00:08:02> 00:08:06:	diversity and affordability, particularly in urban areas like Metro Vancouver
00:08:06> 00:08:07:	and the Fraser Valley,
00:08:07> 00:08:09:	is the creation of complete,
00:08:09> 00:08:12:	compact communities, and this is work that's at the heart
00:08:12> 00:08:15:	of a strategy that's being developed by staff and my
00:08:15> 00:08:19:	ministry and municipal affairs and the Ministry of Transportation and
00:08:19> 00:08:26:	Infrastructure around, effectively integrating land use and transportation planning decisions.
00:08:26> 00:08:28:	So the idea is in building the communities of the
00:08:28> 00:08:29:	future.
00:08:29> 00:08:33:	Ones that are diverse, affordable and resilient and connected by
00:08:33> 00:08:35:	efficient transportation systems.
00:08:35> 00:08:39:	We know that families and people thrive when their communities
00:08:39> 00:08:43:	are truly livable and that means needing access to reliable
00:08:43> 00:08:48:	systems that link together neighborhoods and regions services that people
00:08:48> 00:08:50:	depend on. The jobs that they have,
00:08:50> 00:08:53:	green spaces and the amenities that everybody looks for in
00:08:53> 00:08:55:	the communities that they live.
00:08:55> 00:08:57:	So we're hoping to have much more to say about

00:08:57> 00:09:00:	this approach that's being developed in the months ahead,
00:09:00> 00:09:02:	but. It is already underway.
00:09:02> 00:09:05:	The work is already underway in parts of Metro Vancouver.
00:09:05> 00:09:10:	Supportive policy agreements between Translink and local governments are bridging
00:09:10> 00:09:13:	the gaps between large transit projects like the Broadway Sky
00:09:13> 00:09:17:	Train extension in Vancouver and the New Surry Langley Sky
00:09:17> 00:09:21:	train and how the land around them is being used.
00:09:21> 00:09:24:	So as we build complete compact communities,
00:09:24> 00:09:29:	we're supporting affordability, economic growth and community health,
00:09:29> 00:09:32:	and we know that the development of these communities is
00:09:32> 00:09:34:	going to help us reach our collective climate goals as
00:09:34> 00:09:34:	well.
00:09:34> 00:09:36:	So we recognize that local governments are.
00:09:36> 00:09:39:	Leaders in climate action. I hear from them all the
00:09:39> 00:09:42:	time about the innovative projects that they are undertaking and
00:09:42> 00:09:45:	their goals and aspirations in the provinces here to support
00:09:45> 00:09:48:	them. So we have set aside \$11 million to help
00:09:48> 00:09:52:	continue to work and support local governments in the design
00:09:52> 00:09:54:	of complete and compact communities.
00:09:54> 00:09:56:	And in the coming months my colleague,
00:09:56> 00:09:59:	Minister Heyman from the Ministry of Environment and Climate change
00:09:59> 00:10:00:	strategy.
00:10:00> 00:10:03:	He and I are establishing a new program that will
00:10:03> 00:10:06:	support local governments directly in their broad climate actions.
00:10:06> 00:10:10:	So each and everyone of you as professionals in real
00:10:10> 00:10:11:	estate and land use.
00:10:11> 00:10:15:	We have local government representatives here today and housing advocates.
00:10:15> 00:10:18:	You're all key partners in this work.
00:10:18> 00:10:20:	I know that many of you are already collaborating on
00:10:21> 00:10:22:	Community development,
00:10:22> 00:10:26:	planning and creative ways to contribute to building sustainable regions
00:10:26> 00:10:28:	across the province and at the same time,
00:10:28> 00:10:32:	my ministry has been focused on taking some foundational steps
00:10:32> 00:10:36:	to help support local governments and the development

	sector.
00:10:36> 00:10:40:	In the fall we made legislative changes that give local
00:10:40> 00:10:43:	governments more tools to simplify and to speed up and
00:10:43> 00:10:45:	streamline their development,
00:10:45> 00:10:48:	approvals, processes. And again, this is to help get the
00:10:48> 00:10:51:	homes that people need built faster,
00:10:51> 00:10:55:	so local governments can now hold public hearings for zoning
00:10:55> 00:10:59:	bylaw amendments as long as they are consistent with the
00:10:59> 00:11:04:	official community plan and they can actually not hold public
00:11:04> 00:11:05:	hearings, as the case may be.
00:11:05> 00:11:07:	When that the zoning amendment.
00:11:07> 00:11:09:	It is consistent with the official community plan,
00:11:09> 00:11:11:	which is kind of a 180 or a switch on
00:11:11> 00:11:13:	the default setting for local governments.
00:11:13> 00:11:18:	They can also delegate decisions on minor development variance permits
00:11:18> 00:11:19:	to staff,
00:11:19> 00:11:22:	and these are tools that are allowing local governments to
00:11:22> 00:11:26:	move developments forward more efficiently at bypassing some of the
00:11:26> 00:11:29:	barriers that we've seen and speeding up housing approvals.
00:11:29> 00:11:32:	These are these tools are low hanging fruit if you
00:11:32> 00:11:36:	will that were identified through consultation with housing providers and
00:11:36> 00:11:37:	builders.
00:11:37> 00:11:40:	Which includes folks from the ULI local governments,
00:11:40> 00:11:45:	housing advocates and other important stakeholders and it's part of
00:11:45> 00:11:48:	the ongoing development approvals process review.
00:11:48> 00:11:52:	And while these amendments affect almost all of BC's 188
00:11:52> 00:11:54:	local governments,
00:11:54> 00:11:56:	I do need to note that they don't apply to
00:11:56> 00:11:56:	Vancouver,
00:11:56> 00:11:59:	as the city already has the broader ability to delegate
00:11:59> 00:12:00:	matters to staff,
00:12:00> 00:12:03:	and unlike official community plans,
00:12:03> 00:12:06:	that most BC local governments undertake,
00:12:06> 00:12:10:	Vancouver's official development plans don't require public hearings,
00:12:10> 00:12:12:	so it's a different situation in the city of Vancouver.
00:12:12> 00:12:15:	But we are in close touch with the city and
00:12:15> 00:12:18:	very committed to working together to support Vancouver's

	plans.
00:12:18> 00:12:21:	And the work that they're doing to improve their development,
00:12:21> 00:12:24:	approvals, processes as well. And these are legislative changes that
00:12:24> 00:12:28:	build on the work of the the local government development
00:12:28> 00:12:31:	approvals program in which we've been able to provide \$15
00:12:31> 00:12:34:	million to help local governments.
00:12:34> 00:12:36:	Again modernize and streamline their development,
00:12:36> 00:12:41:	permitting and approvals. So 43 local governments across BC and
00:12:41> 00:12:44:	that includes 9 communities in Metro,
00:12:44> 00:12:47:	van and three in the Fraser Valley were approved under
00:12:47> 00:12:48:	the program.
00:12:48> 00:12:49:	And those projects are now.
00:12:49> 00:12:53:	Underway another important step that we've taken on housing supply
00:12:53> 00:12:57:	and affordability is the requirement for local governments to develop
00:12:57> 00:12:58:	housing needs,
00:12:58> 00:13:02:	reports. Every communities housing needs are unique to itself and
00:13:02> 00:13:05:	local governments know best how to address them.
00:13:05> 00:13:09:	Since the program started, there are 144 local governments and
00:13:09> 00:13:13:	seven modern treating nations that have received funding that includes
00:13:13> 00:13:16:	almost every community in Metro van in the Fraser Valley
00:13:16> 00:13:19:	and and. This means that communities across BC now have.
00:13:19> 00:13:23:	Detailed and relevant information to help them make the best
00:13:23> 00:13:28:	decisions for housing in their communities and that benefits everybody.
00:13:28> 00:13:31:	It benefits community partners like nonprofit housing providers,
00:13:31> 00:13:34:	home builders, and mostly most importantly,
00:13:34> 00:13:36:	the people who need homes.
00:13:36> 00:13:39:	The reports that most of them are now complete.
00:13:39> 00:13:41:	We're already starting to see how they're helping to shape
00:13:41> 00:13:44:	planning and land use decisions around the gaps that communities
00:13:44> 00:13:46:	are experiencing in the housing continuum,
00:13:46> 00:13:49:	and this is important work that's going to continue to
00:13:49> 00:13:51:	guide us all as we build healthier communities.
00:13:51> 00:13:55:	Throughout the province we've also implemented legislative changes allowing local

00:13:55> 00:13:59:	governments to use their zoning bylaws to require new housing
00:13:59> 00:14:02:	in multifamily residential areas to be developed as rental units
00:14:02> 00:14:05:	or preserved as existing rentals,
00:14:05> 00:14:08:	and this is an authority that's already giving many communities
00:14:08> 00:14:10:	like Burnaby and Richmond and Vancouver.
00:14:10> 00:14:14:	Another tool, another way to address the housing crisis.
00:14:14> 00:14:18:	In addition, we're developing a guide for local governments that
00:14:18> 00:14:21:	outlines good practices for supporting new rental housing supply,
00:14:21> 00:14:24:	and that's expected to be ready early this year,
00:14:24> 00:14:28:	so an incredible amount of work has been done since
00:14:28> 00:14:28:	2018,
00:14:28> 00:14:31:	and yet we know that the housing crisis persists.
00:14:31> 00:14:33:	We know that not there's not one solution that's going
00:14:33> 00:14:35:	to lift us out of the crisis,
00:14:35> 00:14:37:	just the way that no one issue created it,
00:14:37> 00:14:40:	but our government has chosen the path of working closely
00:14:40> 00:14:42:	with local governments with developers,
00:14:42> 00:14:44:	and with housing advocates, and we're going to continue down
00:14:44> 00:14:44:	that.
00:14:44> 00:14:48:	Path we know that each community has its own unique
00:14:48> 00:14:48:	needs.
00:14:48> 00:14:50:	We know that it's important that we get the right
00:14:50> 00:14:52:	housing built for British Columbians,
00:14:52> 00:14:56:	so we've chosen to engage with colleagues across ministries at
00:14:56> 00:14:58:	the federal level as well on the work that we're
00:14:58> 00:15:00:	doing so that when houses are built,
00:15:00> 00:15:04:	the vital transportation and the infrastructure that services people to
00:15:04> 00:15:07:	provide what they need are also in place.
00:15:07> 00:15:09:	And this is work that's very critical,
00:15:09> 00:15:12:	especially now as we emerge from the pandemic and continue
00:15:12> 00:15:15:	to support the long term sustainability of communities across the
00:15:15> 00:15:16:	province.
00:15:16> 00:15:18:	I really love the work that I'm doing.
00:15:18> 00:15:20:	I'm very excited to have dug into something and be

00:15:20> 00:15:23:	able to bring it forward from my own local government
00:15:23> 00:15:25:	experience here to the provincial level.
00:15:25> 00:15:28:	I'm very motivated by what we've accomplished so far,
00:15:28> 00:15:30:	and I know there's a heck of a lot more
00:15:30> 00:15:30:	to do,
00:15:30> 00:15:32:	so I'm eager to dive into a conversation with Duncan
00:15:32> 00:15:35:	and that continue all the hard work that we've been

00:29:36> 00:29:39:	not chase growth, right? So how do you?

00:30:34> 00:30:38:	which will which will come forward later this year or
00:30:38> 00:30:41:	earlier this spring and starting to see that kind of

00:32:03> 00:32:05:	Metro Vancouver and on the South Coast of the island.

00:32:49> 00:32:54:	helping to provide the funding that nonprofit housing providers need

00:32:56> 00:33:00:	cost of housing and the cost of delivering affordable housing
00:33:00> 00:33:01:	to people.

00:33:03> 00:33:06:	And really it's kind of working in tandem.

00:34:25> 00:34:27:	regional districts, towns, and villages,

00:34:45> 00:34:47:	into some of the questions I've seen in the chat

00:34:57> 00:34:59:	How everyone to phrase it with the province and your
00:35:00> 00:35:01:	ministry in particular.

00:35:06> 00:35:10:	Whether it's on on the host nations you know with
00:35:10> 00:35:12:	with them directly or in places.
00:35:12> 00:35:15:	Like certain communities in in with urban indigenous populations,
00:35:15> 00:35:17:	what what? What is that?
00:35:17> 00:35:19:	What is that situation been like and what are you
00:35:19> 00:35:20:	working on or or what?
00:35:20> 00:35:22:	What might Members want to know about that relationship or
00:35:22> 00:35:24:	ongoing development of that relationship?
00:35:25> 00:35:28:	Thanks, that's a really important question,
00:35:28> 00:35:30:	I think, and we've seen you know this is a
00:35:30> 00:35:31:	government.
00:35:31> 00:35:34:	I think that really understands well,
00:35:34> 00:35:36:	some of the concerns and some of the needs and
00:35:36> 00:35:40:	indigenous communities are experiencing and and the the challenges that
00:35:40> 00:35:41:	they face.
00:35:41> 00:35:42:	And so I'm really proud to be part of a
00:35:42> 00:35:43:	government that is.
00:35:43> 00:35:48:	The first government in British Columbia that's invested directly in
00:35:48> 00:35:50:	housing in directly in indigenous communities,
00:35:50> 00:35:54:	building those partnerships and again being a convener of bringing
00:35:54> 00:35:55:	people together.
00:35:55> 00:35:59:	Nations and local governments is really really important.
00:35:59> 00:36:03:	We provide funding to First Nations and local governments to
00:36:03> 00:36:05:	help bring them together,
00:36:05> 00:36:08:	so even just something as simple as a few \$1000
00:36:09> 00:36:14:	that helps bring councils and indigenous leaders together to discuss.
00:36:14> 00:36:17:	The issues that they're facing and work towards,
00:36:17> 00:36:22:	for example, developing protocol agreements or agreements

	on how they're
00:36:22> 00:36:25:	going to work together is might seem unrelated to housing,
00:36:25> 00:36:29:	but it isn't because it's about the relationship that they
00:36:29> 00:36:30:	both need and and understanding.
00:36:30> 00:36:33:	We also know that as First Nations communities,
00:36:33> 00:36:36:	indigenous communities are growing. They need services,
00:36:36> 00:36:40:	so they need water. They need sewage treatment,

00:37:19> 00:37:22:	action plan that is has been put forward is around
00:37:22> 00:37:25:	more inclusive governance at the regional level.
00:37:25> 00:37:27:	So we have a lot of work to do.
00:37:27> 00:37:29:	We've we've done since. There's been some phenomenal
00.07.27> 00.07.23.	work that's
00:37:29> 00:37:32:	been done with respect to treating nations and and that

00:37:32> 00:37:35:	but there are a lot of non treating nations that
00:37:35> 00:37:39:	are there community members that are living in local government
00:37:39> 00:37:43:	areas that don't have the same kind of participation or
00:37:43> 00:37:45:	say at a council or board table.

00:40:11> 00:40:13:	the deep respect that we all have.

00:40:16> 00:40:19:	know their communities best is is something the province very
00:40:19> 00:40:20:	takes very very seriously.
00:40:20> 00:40:24:	So we use that. We have a democratic system.
00:40:24> 00:40:28:	We elect representatives to represent us at the Council or
00:40:28> 00:40:31:	islands trust table or a regional district table.
00:40:31> 00:40:33:	And so we place in them our faith and confidence
