00:02:24 --> 00:02:29: institutions, foundations,

00:02:29 --> 00:02:33: science, culture, sport, entertainment, fun. Over the past 10

00:02:33 --> 00:02:35: years,

00:02:37 --> 00:02:39: you have built this city from scratch. This is a

00:02:39 --> 00:02:40: fact of what should be more.

00:02:41 --> 00:02:44: It's time for us.

00:02:44 --> 00:02:48: Us.

00:02:48 --> 00:02:52: We want our voice to be heard not only on

00:02:53 --> 00:02:56: the Internet. We want to co-decide, we will shout loudly

00:02:56 --> 00:02:59: when you destroy our planet, saying that the climate crisis

00:02:59 --> 00:03:03: and at what prices we will protest when we hear

00:03:03 --> 00:03:07: that someone in us is not a normal person, or

00:03:07 --> 00:03:07: that he does not deserve respect, we want more space

00:04:03 --> 00:04:07: something about what is going to happen in Lubin next  
00:04:07 --> 00:04:08: year?  
00:04:09 --> 00:04:13: Well, it is not without reason that we present this  
00:04:13 --> 00:04:17: film today, we show it fl on the occasion of  
00:04:17 --> 00:04:21: how many different meetings. Only first of all we won  
00:04:21 --> 00:04:25: this title of the European Youth Capital and next year,  
00:04:25 --> 00:04:28: but we will represent. It can be said not only  
00:04:29 --> 00:04:33: Polish cities, but all those that fill are involved in  
00:04:33 --> 00:04:37: this generational change, but this is how the involvement of  
00:04:37 --> 00:04:41: young people in all these processes related to it was  
00:04:41 --> 00:04:42: thought out.  
00:04:42 --> 00:04:47: Demolishing III. The cities of such a film, which they  
00:04:47 --> 00:04:50: need not only for life, but for this activity of  
00:04:50 --> 00:04:55: fill, which we believe that there is still not enough

00:05:18 --> 00:05:21: changes in The United Kingdom, a huge empowerment of all  
00:05:22 --> 00:05:26: environments that wanted to develop a strategy with us,  
implement.  
00:05:26 --> 00:05:30: Today we have another lublin 2030 strategy, and let me  
00:05:30 --> 00:05:34: remind you that in 2012 the strategy after 2 years  
00:05:34 --> 00:05:39: of discussion with all zenjov, alone with universities, with  
business,  
00:05:39 --> 00:05:43: with of course also with experts, with experts with different  
00:05:43 --> 00:05:43: ones.  
00:05:44 --> 00:05:48: These young people were the senior communities and this  
film  
00:05:48 --> 00:05:51: project Lublin 2020 is just reaching the port. So we  
00:05:51 --> 00:05:56: have also implemented the assumption that we have adopted  
and  
00:05:56 --> 00:05:59: we value very much. How many of these partners who  
00:05:59 --> 00:06:03: want to take such co-responsibility with us for the city,  
00:06:03 --> 00:06:06: and we believe that to an even greater extent they  
00:06:06 --> 00:06:10: should be young people, because it is for them that  
00:06:10 --> 00:06:14: we have actually prepared these 2 strategic documents.  
00:06:14 --> 00:06:19: And, of course, we are also talking about European values.  
00:06:19 --> 00:06:24: We are talking about democracy, we are talking about

00:06:28 --> 00:06:33: always been multicultural and it is also extremely important  
for  
00:06:33 --> 00:06:37: us that today young people are very sensitive in those  
00:06:37 --> 00:06:42: areas of childhood, which perhaps were of less importance  
for  
00:06:42 --> 00:06:44: our generations of people.  
00:06:44 --> 00:06:48: Let were born in the 50s, 60s because there economics  
00:06:48 --> 00:06:53: absolutely dominated Everything, and today this thinking as if  
the  
00:06:53 --> 00:06:57: film assumes that these foundations are there, but what is  
00:06:57 --> 00:07:01: important is what we build on them, that is, how  
00:07:01 --> 00:07:05: much is sometimes said to us. We have built what  
00:07:05 --> 00:07:08: you could, and we now want to organize the city  
00:07:08 --> 00:07:11: of the evil region in our own way, so we  
00:07:11 --> 00:07:14: say, of course take responsibility.  
00:07:14 --> 00:07:17: On the other hand, this is a region for Poland.  
00:07:17 --> 00:07:20: How much it is necessary to create for this also  
00:07:20 --> 00:07:25: these institutional organizational opportunities to introduce  
young people to co-manage  
00:07:25 --> 00:07:28: the city. We have managed to do it very well  
00:07:28 --> 00:07:31: in this past period of the People's Republic of Poland  
00:07:31 --> 00:07:35: over 10 years of implementation of this Lublin 2020 strategy,  
00:07:35 --> 00:07:38: because not everyone listening to the viewers knows about it,  
00:07:39 --> 00:07:42: of course, but this dynamic change of Lublin and this  
00:07:42 --> 00:07:45: success of Lublin is primarily the work of people.  
00:07:45 --> 00:07:51: Cultures and non-governmental organizations that did not  
compete with us  
00:07:51 --> 00:07:55: in the race for the title of European Capital of  
00:07:55 --> 00:07:59: Culture we lost to Wroc??aw L, but the film we  
00:07:59 --> 00:08:03: won this change of our city in the context of  
00:08:04 --> 00:08:08: will such a fl, which we would not even expect  
00:08:08 --> 00:08:11: pride in what we do and pride in what we  
00:08:11 --> 00:08:16: have achieved. Purpose and if we look at the institutions.  
00:08:16 --> 00:08:21: And cultures ourselves probably did not even think how they  
00:08:21 --> 00:08:26: are an important mechanism of these changes like a film,  
00:08:26 --> 00:08:28: how they actually cause.  
00:08:28 --> 00:08:32: The film that this machine is starting to work more  
00:08:32 --> 00:08:36: dynamically moments for sociological changes in the city and  
this  
00:08:36 --> 00:08:40: is, among other things, the reason why we set ourselves  
00:08:40 --> 00:08:43: new goals and this European Youth Capital is also to

00:08:43 --> 00:08:46: be such an impulse for social changes in our city  
00:08:46 --> 00:08:50: and, of course, for changes related to the model of  
00:08:50 --> 00:08:51: city management.  
00:08:51 --> 00:08:55: Sfl Mr. President, you said that a lot has happened  
00:08:55 --> 00:08:58: in Lublin and indeed the city has changed a lot.  
00:08:58 --> 00:08:59: Hmm.  
00:09:00 --> 00:09:04: Over the last decade, but please tell me more, young  
00:09:04 --> 00:09:08: people want to change the world, arrange them in their  
00:09:08 --> 00:09:12: own way, but you need to attract these young people  
00:09:12 --> 00:09:15: to the city in some way. Well, what can the  
00:09:15 --> 00:09:19: new residents of Lublin count? Those who are considering a  
00:09:19 --> 00:09:23: place where for a moment a shorter or longer moment.  
00:09:23 --> 00:09:26: They will stop. What offer for?  
00:09:27 --> 00:09:30: Lublin has new residents, but also the current ones. And  
00:09:30 --> 00:09:33: what will be this offer in the coming years? What  
00:09:33 --> 00:09:35: do you want to encourage residents?  
00:09:36 --> 00:09:41: I would even modify your question sl before we attract,  
00:09:41 --> 00:09:47: or maybe otherwise, before we show effectiveness in  
attracting young  
00:09:47 --> 00:09:51: people, we should not let them out of our city?  
00:09:51 --> 00:09:55: Or let me remind you that Lublin is a wile  
00:09:55 --> 00:09:57: city in the academic 5.  
00:09:57 --> 00:10:01: Film 5 position when it comes to the academic potential  
00:10:01 --> 00:10:06: of lel bones, that is, over 60000 Polish students, ul.  
00:10:06 --> 00:10:09: And this is more than 7400 international students ll all  
00:10:09 --> 00:10:13: over the world from more than 100 countries fl and  
00:10:13 --> 00:10:16: here, of course, with great merit for the Union to  
00:10:16 --> 00:10:19: do their studies, first of all the Medical University and  
00:10:20 --> 00:10:24: the Maria Curie Sk??odowska University, but all universities  
today have  
00:10:24 --> 00:10:27: a large foreign investment. How much if we look at  
00:10:27 --> 00:10:30: this page here, then in a moment I will say  
00:10:30 --> 00:10:34: Philco stops young people, but it is worth saying that  
00:10:34 --> 00:10:36: we have our own small success.  
00:10:36 --> 00:10:40: Fl, if once a large group of high school graduated  
00:10:40 --> 00:10:45: and chose a university throughout Poland, today 3/4 choose  
a  
00:10:45 --> 00:10:50: Lublin university or more than 3/4, and in turn if  
00:10:50 --> 00:10:55: you finish ll studies in Lublin, then felt felt changes  
00:10:55 --> 00:10:59: during the year, but every year, but in general we  
00:10:59 --> 00:11:03: are aiming for a definite larger part to stay in  
00:11:03 --> 00:11:07: Lublin. You have to remember that style.  
00:11:07 --> 00:11:11: Students and graduates come from several regions, so they

come

00:11:11 --> 00:11:14: back together, but we have a movie. I think that

00:11:14 --> 00:11:17: at the moment about 50% of those graduates who become

00:11:17 --> 00:11:21: albers, if we take into account people living in Lublin,

00:11:21 --> 00:11:24: again nearly 3/4 stay in Lublin, that is, they have

00:11:24 --> 00:11:27: a job. But what is important in the game they

00:11:27 --> 00:11:30: are optimistic about the future in the sense, and not

00:11:30 --> 00:11:34: only professional promotions, not only in the sense of the

00:11:34 --> 00:11:35: possibility of building.

00:11:36 --> 00:11:40: How many of these economic foundations of their lives, but

00:11:40 --> 00:11:44: also seeing the city as a cool movie to live

00:11:44 --> 00:11:47: as a quality of life city in a high quality

00:11:47 --> 00:11:51: of life as a city that provides them with all

00:11:51 --> 00:11:55: that motivations they need are very different. I remember

how

00:11:55 --> 00:11:59: much one of my interlocutors came to me, feel, who

00:11:59 --> 00:12:03: sent an e-mail earlier, arranged a chill, worked in a

00:12:03 --> 00:12:06: large investment fund in Japan.

00:12:06 --> 00:12:09: How much and said that they decided it was time

00:12:10 --> 00:12:13: to go home as a filter wife, because as it

00:12:13 --> 00:12:17: turned out later, he graduated from high school in Lublin,

00:12:17 --> 00:12:21: and then somewhere in the world all the time and

00:12:21 --> 00:12:24: he followed what we do in Lublin. For him, the

00:12:24 --> 00:12:28: basic motivation was the purity of the air green city,

00:12:28 --> 00:12:32: the film just a culturally attractive city with a huge

00:12:32 --> 00:12:36: amount of Ill, projects and a city in which he

00:12:36 --> 00:12:36: also felt.

00:12:36 --> 00:12:40: In such a subject of what is happening, for example,

00:12:40 --> 00:12:43: he asked me in detail whether he will have the

00:12:43 --> 00:12:47: concept of plinths, a spatial development plan and will be

00:12:47 --> 00:12:51: consistently implemented in one of the districts that plans to

00:12:51 --> 00:12:55: buy an apartment. So imagine that as many young people

00:12:55 --> 00:12:58: as there are in our country, or how many can

00:12:58 --> 00:13:02: be, will have a very different approach from what they

00:13:02 --> 00:13:05: expect from the city, but certainly in the first place

00:13:05 --> 00:13:06: finding a job.

00:13:06 --> 00:13:11: The film certainly opportunities for development and certainly

opportunities for

00:13:11 --> 00:13:15: further education. What is also important today is also the

00:13:15 --> 00:13:18: city is available by transport FI to Warsaw one and

00:13:23 --> 00:13:26: expressways did their job, but as long as they were

00:13:30 --> 00:13:33: of the province were involved in the construction of the  
00:13:33 --> 00:13:36: airport in order to also bring the world closer to

00:13:50 --> 00:13:55: associations, because the infrastructure will always be basic  
and this  
00:13:55 --> 00:14:01: technical infrastructure social infrastructure. But there is  
something else immeasurable,  
00:14:01 --> 00:14:05: of which I am extremely proud that we managed to  
00:14:05 --> 00:14:07: build in Lublin. This is a lel movie.  
00:14:09 --> 00:14:12: Such a belief, except that Lublin is a fih city  
00:14:12 --> 00:14:15: of FI and a city. How much ensuring a high  
00:14:15 --> 00:14:19: quality of life fl is also served by these great  
00:14:19 --> 00:14:23: projects of the environment of the anniversary of Lublin 400  
00:14:23 --> 00:14:28: fifty years of signing the FII Polish-Lithuanian Union here. Of  
00:14:28 --> 00:14:32: course, all the projects that we carry out every year,  
00:14:32 --> 00:14:36: but also the internationalization of the city. Suddenly, it  
turned  
00:14:37 --> 00:14:38: out that we actually have.  
00:14:39 --> 00:14:42: The film from over 100 student countries can be found  
00:14:42 --> 00:14:46: on the street by people speaking different languages. It got  
00:14:46 --> 00:14:48: worldly. Lublin used to be not like that and for  
00:14:49 --> 00:14:52: young people it is extremely important. They are today, if  
00:14:52 --> 00:14:55: not proud, then how much can you say satisfied with  
00:14:55 --> 00:14:56: the city?  
00:14:57 --> 00:15:01: Above all, older people are proud, but they have the  
00:15:01 --> 00:15:05: opportunity to compare with what was once for young III  
00:15:05 --> 00:15:08: the world is open, so they rather compare in the  
00:15:08 --> 00:15:13: context of higher expectations or somewhere in Barcelona it  
is  
00:15:13 --> 00:15:17: and hmm, the minister of our partner city, this is  
00:15:17 --> 00:15:20: a film. Why is it not with us? But nevertheless,  
00:15:20 --> 00:15:24: we see a very good mood among young people. How  
00:15:24 --> 00:15:27: many moments would you pull in here?  
00:15:27 --> 00:15:30: To work for the city. And now this strategy is  
00:15:30 --> 00:15:33: to show in which areas there are priorities, what action  
00:15:33 --> 00:15:36: the city is taking and will take to attract investments.  
00:15:37 --> 00:15:40: But now the question is, what investments? And here we  
00:15:40 --> 00:15:44: are talking about this process of creating business

ecosystems that

**00:15:44 --> 00:15:48:** today meet the expectations of young people, because we are

**00:15:48 --> 00:15:51:** talking here about the ICT sector and modern business services,

**00:15:52 --> 00:15:56:** about medicine, about biotechnology, but we are also talking about

**00:15:56 --> 00:15:57:** the machine industry.

**00:15:57 --> 00:16:02:** We are talking, if also about modern food processing, because

**00:16:02 --> 00:16:07:** the region has an agricultural and industrial character. This is

**00:16:07 --> 00:16:12:** a film not only efficient hillel agriculture, but one of

**00:16:12 --> 00:16:16:** the most ecological and so on and so on. There

**00:16:16 --> 00:16:19:** are a lot of arguments to say yes I choose

**00:16:19 --> 00:16:23:** Lublin for reasons that everyone defines individually.
